

FORMS AUTOMATION— This module is for automating the forms associated with the business process. The data required to complete each form is collected through an intelligent interview regardless of the number of forms that are part of the business process.

BUSINESS AUTOMATION – This module provides for a higher-level Business Process Management (BPM) workflow that is utilized to control what action is taken on the collected data and is used for reviews, approvals, integrations to other systems, and tracking progress with multiple dashboards.

STAKEHOLDER ENGAGEMENT – This module automates and consolidates the agency's communication with all stakeholders. There are unlimited email-, letter-, and SMS-templated notifications and reminders. Status updates are captured on configurable dashboards that are unique for each user in the system.

SYSTEMS INTEGRATIONS – This Module is the conduit for the connection to the other agency systems, allowing the input and output of data for each of the processes. The field mapping tables between our systems and the integrated systems helps identify integration issues.

SECURITY – This Module ensures that all the data that resides in the Platform is encrypted and secure at rest and in transit. We are FedRAMP certified in the Amazon GovCloud and have current ATOs.
